Registration/Cancellation Policies

- All cancellations or changes in enrollment must be submitted to the front office in writing or via email to Jen Masuda at jen@altaclub.com.
- Cancellation requests must be submitted two weeks prior to the start of the week originally signed up for.
- There are no refunds or make-ups for any missed days by a participant.
- Any participant who must leave his/her enrolled program for medical reasons will receive a pro-rated credit or refund, subject to medical verification.
- Children enrolling in the ATCC Summer Camp program should be water safe and able to swim the width of the pool. If they are not water safe they will be required to wear a life vest until they are water safe.

Code of Conduct for Minors While at ATCC

ATCC strives to provide an environment for all children that is safe, accepting, and caring. Consequently, we must place expectations and obligations on all children when at the Club. This applies to children who are under the care of Club employees or children in the care of their families.

Principles of Courtesy to be Observed:

- Proper respect and courtesy must always be shown to employees and members of the Club.
- "Treat others as you would like to be treated" should guide the child's behavior.
- Bullying or harassment in any form will not be tolerated.
- Upon being corrected, a child must show a willingness to improve the situation or behavior.

Appropriate Use of Facilities:

- Children must use all areas of the Club facility appropriately.
- Each child must share in the responsibility of keeping the restrooms, locker room, clubhouse, and grounds clean and orderly.

Prohibited Items:

- Skateboards, roller blades/skates, and scooters are prohibited on Club property including parking lots.
- Tobacco, fireworks, matches, alcohol, drugs, or weapons are not permitted at the Club.
- Magazines, books, games, other printed material, or music having questionable or offensive subject matter or illustrations are strictly prohibited.
